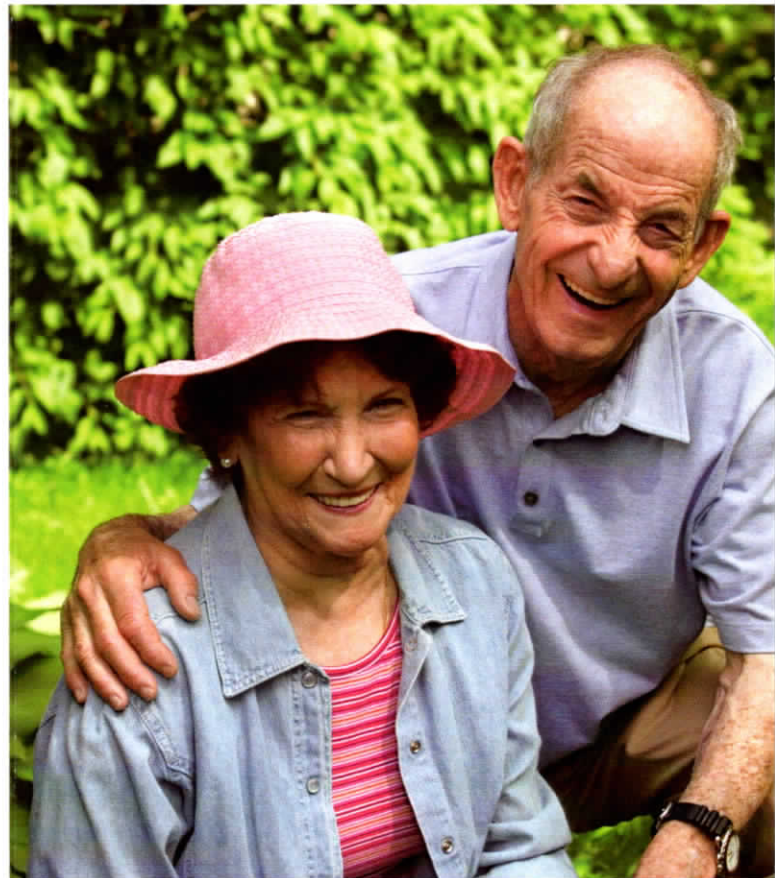

FAQs

Do I have to get a doctor's referral?

While a home health client can be referred by anyone, doctor, hospital discharge planner, self, family, etc. a doctor must sign for services.

Who chooses which Home Healthcare?

The ultimate decision belongs to the patient. In the same manner you can choose which doctor you go to, you also have the choice of Home Healthcare agencies.

Who pays for Tex Med Home Health's services?

If you meet the criteria for Medicare Home Health Care, the services are free to the patient.

Who is eligible for Medicare Home Health Care?

- Doctor must agree that you need care in your home
- You must need at least one of the following: intermittent skilled nursing care, Physical, Occupational or Speech therapy services and
- You must be home bound. This means that you are normally unable to leave home on your own. Being home bound means that leaving home is a major effort.
- The Home Health Agency must be approved by the Medicare program.
